Statement of main factors taken into account in making the above declaration

In making the above declaration, the main factors which have been taken into account by the Board of Directors are as follows:

- In 2025/26 the Trust delivered its financial plan.
- The Trust's accounts for 2025/26 have been prepared on the going concern basis and this has been agreed by the external auditor as appropriate.
- The Trust Board, through its Finance, Commercial and Investment Committee, scrutinises the Trust's financial position and forecasts and has not concluded that the Trust's financial position would prevent it from delivering its full range of clinical services.
- Assurance has been received from external auditors in relation to the annual accounts and from internal auditors regarding the robustness of the Trust's financial systems and processes.
- The Trust's Board Assurance Framework acknowledges the financial risks linked to the uncertain economic environment, but recognises that some of the risk in this area is out of the Trust's control (inter alia the deconstruction of block contracts and unanticipated apportionment of specialist commissioning income).
- The Trust's 2026/27 business plan is recognised by the Board as ambitious but achievable, and no material concerns have been raised by clinical groups about being unable to deliver healthcare with the resources they have available (in terms of financial, personnel, or estates).
- The Trust Board recognises the Trust retains an underlying deficit and that there is a high degree of risk in the 2026/27 financial plan, which will be disclosed in the Trust's Annual Report. The Trust has established a 'Future Ready' programme to build organisational momentum in achieving its cost improvement target which, if delivered, will play a significant role in enabling the Trust to deliver the overall financial plan.
- The Trust has implemented more robust cost controls in 2025/26 such as vacancy freezes and reductions in temporary staffing spend.
- The Trust has continuing support from commissioners of its clinical services.
- The Trust has no provider licence conditions in place from its regulatory body relating to financial performance.


