	In 2024/25 the Trust delivered its financial plan, which was a surplus. The Trust's accounts for 2024/25 have been prepared on the going concern basis and this has been agreed by the external auditor as appropriate.  The Trust Board, through its Finance, Commercial and Investment Committee, scrutinises the Trust's financial position and forecasts and has not concluded that the Trust's financial position would prevent it from delivering its full range of clinical services.  Assurance has been received from external auditors in relation to the annual accounts and from internal auditors regarding the robustness of the Trust's financial systems and processes.  The Trust's Board Assurance Framework acknowledges the financial risks linked to the uncertain economic environment, but recognises that much of the risk in this area is out of the Trust's control (for example the developments in specialised commissioning and high levels of inflation).  The Trust's 2025/26 business plan is recognised by the Board as ambitious but achievable, and no material concerns have been raised by clinical groups about being unable to deliver healthcare with the resouces they have available (in terms of financial, personnel, or estates).  The Trust Board recognises that there is a high degree of risk in the 2025/26 financial plan. However, the Trust is confident of delivering its cost improvement programme that it will support it to deliver the overall financial plan.  The Trust has benefited from additional cash funding during 2024/25, whilst steps are being taken to deliver cash releasing cost improvement schemes, more closely peg capital expenditure to depreciation, and to implement more robust cost controls such as vacancy freezes and a new 'no PO, no pay 'policy.
